Exhibition Conditions:

- **No entry fee is charged to members of the Bright Art Gallery - membership must be paid up for 2017.** The Entry Fee for **non-member exhibitors is \$20** in total. Membership to the Bright Art Gallery is \$15 per calendar year. Membership form may be completed and fee paid when delivering your work. - Works entered must be original work by the artist. All works must be for sale.
- All sold items may be replaced by the artist with new work for the duration of the exhibition. Make sure you will add new items to your existing entry form at the gallery or fill in an additional entry form with each new delivery.
- The gallery reserves the right to reject any unsuitable entries to ensure a high overall standard.
- The selling price shall include a commission of 25% to the gallery.
- **Two dimensional art works:** Paintings, Photographs, Drawings, Handmade prints – any subject, any medium, traditional or contemporary, framed works or unframed stretched canvasses. All works are to be suitably presented with D-rings and hanging wires attached (no protruding hooks or screws). Ready for hanging and must be clearly labeled on the back with artists name, address & phone number, title of work, medium and selling price.
Maximum 8 entries in total per artist, no more than 3 large works (large is 1-4 m²).
- **Other categories** : Ceramics, Glassware, Sculptures (indoor & outdoors), Jewelry, Silverware, Beading, Wearable Art, Leadlight, Woodwork, Mosaics, Cards (Artist original work only). The number of artist works on display may be reduced to fit within the available space. Works may be held in reserve to replace sold items. All items delivered to the gallery need to be entered on the artist entry form with a description and selling price for each item.
- For **publicity** purposes the gallery invites you to **email jpg images** of work you are entering to manager@brightartgallery.org.au. They may be used on the gallery's Facebook, website & advertising.
- **Entry forms must be received at the gallery by Mon 14 Nov.**
- **Delivery of work is on Fri 18 Nov 10am-2pm or Sat 19 Nov 1-3pm or Sun 20 Nov 1-3pm.**
If unable to deliver on these days please contact the gallery to make alternative arrangements.
No works will be accepted after 3pm Sun 20 November.
- **Collection of unsold work on Tue 31 Jan and Wed 1 Feb from 10am to 2pm.**
If unable to collect at these times, please contact the gallery to make alternative arrangements.
- Artist CV's, business cards, studio flyers etc may be left at the gallery.
- Exhibiting artists are encouraged to man the gallery as many times as they can during the exhibition. Duties consist of greeting visitors and providing general information about the exhibition. It provides an excellent opportunity to network and talk to prospective buyers of your work. A roster will be set up at delivery time. The gallery is run and managed by volunteers only, so your help is very much appreciated. However manning the gallery is **voluntary and not a requirement to exhibit work.**
- Artist payments for sales (except cards) in Dec will be processed in January. All further sales in January will be processed within one month, after the conclusion of the exhibition.
